हम, भारत के लोग, भारत को एक सम्पूर्ण 'प्रभुत्व-संपन्न समाजवादी पंथनिरपेक्ष लोकतंत्रात्मक गणराज्य बनाने के लिए, तथा उसके समस्त नागरिकों को:

51 क. मूल कर्तव्य - भारत के प्रत्येक नागरिक का यह कर्तव्य होगा कि वह -

- (क) संविधान का पालन करे और उसके आदर्शों, संस्थाओं, राष्ट्रध्वज और राष्ट्रगान का आदर करे;
- (ख) स्वतंत्रता के लिए हमारे राष्ट्रीय आंदोलन को प्रेरित करने वाले उच्च आदर्शों को हृदय में संजोए रखे और उनका पालन करे;
- (ग) भारत की प्रभुता, एकता और अखंडता की रक्षा करे और उसे अक्षुण्ण रखे;
- (घ) देश की रक्षा करे और आह्वान किए जाने पर राष्ट्र की सेवा करे;
- (ङ) भारत के सभी लोगों में समरसता और समान भ्रातृत्व की भावना का निर्माण करे जो धर्म, भाषा और प्रदेश या वर्ग पर आधारित सभी भेदभाव से परे हों, ऐसी प्रथाओं का त्याग करे जो स्त्रियों के सम्मान के विरुद्ध हैं;

THE CONSTITUTION OF INDIA

PREAMBLE

WE, THE PEOPLE OF INDIA, having solemnly resolved to constitute India into a **'SOVEREIGN SOCIALIST SECULAR DEMOCRATIC REPUBLIC'** and to secure to all its citizens :

JUSTICE, social, economic and political;

LIBERTY of thought, expression, belief, faith and worship;

EQUALITY of status and of opportunity; and to promote among them all

FRATERNITY assuring the dignity of the individual and the² unity and integrity of the Nation;

IN OUR CONSTITUENT ASSEMBLY this twenty-sixth day of November, 1949, do **HEREBY ADOPT, ENACT AND GIVE TO OURSELVES THIS CONSTITUTION.**

Chapter IV A

FUNDAMENTAL DUTIES

ARTICLE 51A

Fundamental Duties - It shall be the duty of every citizen of India-

- (a) to abide by the Constitution and respect its ideals and institutions, the National Flag and the National Anthem;
- (b) to cherish and follow the noble ideals which inspired our national struggle for freedom;
- (c) to uphold and protect the sovereignty, unity and integrity of India;
- (d) to defend the country and render national service when called upon to do so;
- (e) to promote harmony and the spirit of common brotherhood amongst all the people of India transcending religious, linguistic and regional or sectional diversities; to renounce practices derogatory to the dignity of women;
- (f) to value and preserve the rich heritage of our composite culture;
- (g) to protect and improve the natural environment including forests, lakes, rivers, wild life and to have compassion for living creatures;
- (h) to develop the scientific temper, humanism and the spirit of inquiry and reform;
- (i) to safeguard public property and to abjure violence;
- (j) to strive towards excellence in all spheres of individual and collective activity so that the nation constantly rises to higher levels of endeavour and achievement;
- ¹(k) who is a parent or guardian to provide opportunities for education to his/her child or, as the case may be, ward between age of 6 and 14 years.

Foreword

Entre Jeunes has proven to be a useful manual for teaching and learning French as a foreign language at the school level for about a decade now. However, with the changing times, it became imperative to undertake a detailed revision of this book. This revised edition takes primarily into consideration the mandate to impart and perfect the four basic skills of learning a foreign language i.e. listening, reading, speaking, and writing. Today's learner, though embedded in a local context, is being constantly exposed to the media and Internet as a global citizen in making. The revisions have taken place keeping these aspects in mind.

Some of the structural changes are that the number of lessons has been increased to 12 mainly because the workbook has been merged into the main textbook through a critical selection of pedagogical material. The grammatical elements have been retained in accord with the earlier book. A careful look will reveal that the lesson plans have been redrawn keeping in view the needs of the today's learners. Each lesson starts with a main text or a dialogue followed by the activity "à toi" (now it is your turn) which invites the learner to immediately test what she/he has just learned. This is once again followed by a sub text or a dialogue, which intends to strengthen the knowledge, just acquired. Each lesson ends with two distinct features "I revise what I just now learned" and a gamut of socio-cultural elements reflected through photos, authentic documents and so on. The latter can be used either orally or in groups. In fact, the objective was to empower young students for independent study. In order to make today's learner a team player and a leader, some group and creative activities have been also incorporated which can be exploited orally or through written practice. The glossary at the end is an important addition.

An effort has been made to render the book student friendly. A group of 3 lessons have been clubbed together in a unit with a particular colour which runs through that particular unit. Each unit ends with a "Bilan" or a review of all the four skills.

The Board wishes to express its gratitude to Dr. Sadhana Parashar, Director (Academics, Research, Trainings and Innovation) and Mr. A.H. Ahmed, Joint Director for rendering the much needed guidance throughout this project. The Board would like to place on record its special appreciation to all the members of the revision team for their hard work, perseverance and

valuable contribution. It is due to the excellent teamwork at all levels that the Board is in a position to introduce the revised French Book in the CBSE-affiliated schools in time.

I hope that the revision of this book in the light of critical insights will help students understand the subtleties of the French language as they relate to daily life and they will feel more confident and motivated for learning French as a foreign language. Suggestions for further improvement will be appreciated.
